The Accounting Authority will be responsible to represent the vessel before the air service providers and will be in charge of the Accounting, Administration and settlement of radio bills generated by the ship.



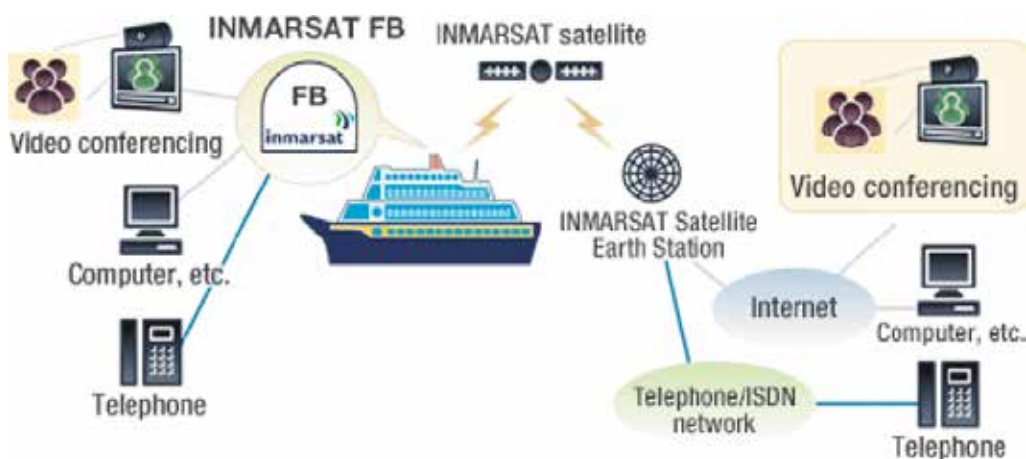
SERVICES

- Sim Cards (for Pre-paid and Post Paid contracts)



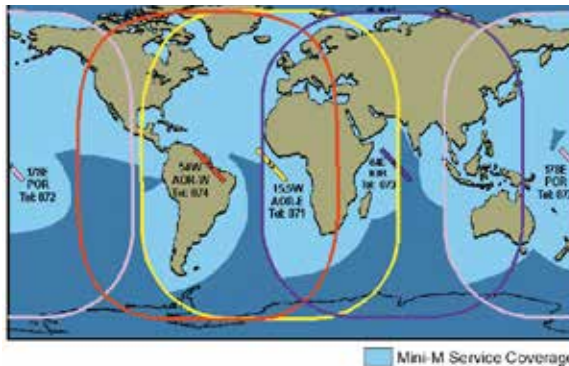
2. Point Service Activation: PSA 3175
